Petra Stupková and Mgr. Pavla Vybíralová, executive directors (hereinafter referred to as the "Controller" or "We")

We take the protection of personal data seriously. In this policy you will find out for what purpose, for what reason and in what way we process your Personal Data. You will also find information on your rights in relation to the protection of Personal Data.

We need some Personal Data for the conclusion and performance of the Contract, and we process some Personal Data on the basis of our legitimate interest. For some purposes we are required by law to process Personal Data (e.g., accounting). In some cases, we use Processors who may have access to your Personal Data. These include, for example, accounting firms or marketing specialists. Where necessary, we will seek your consent to process your Personal Data.

When are we in the position of a Controller? We are the Controller of Personal Data In relation to Users. An overview of the processed Personal Data, including the reasons for their Processing, can be found below. 1. WHAT PERSONAL DATA DO WE PROCESS and HOW?

How do we process personal data? We process your Personal Data only to the extent necessary to achieve the purpose for which the data were collected and when processing we comply with security, technical and organizational rules. The Processing is automated, but we do not perform profiling. The specific purposes of Processing and the categories of Personal Data we process for individual purposes are explained in detail in the following section.

Special categories of Personal Data. We do not process any sensitive Personal Data about you.

2. OUR PROCESSORS

Legal obligations. We may disclose personal data to third parties outside the Processor if required to do so by law or in response to lawful requests by public authorities or at the request of a court in litigation.

3. WHAT MEASURES HAVE WE TAKEN TO PROTECT YOUR PERSONAL DATA?

Technical and organizational measures. We take data security very seriously and that is why we constantly work to ensure that your Personal Data is protected. When opting for measures, we take into account the scope of processing, the riskiness of processing and/or the state of our technology.

- We back up data regularly;
- we update anti-virus software systems;
- we use a secure https protocol;
- access passwords to information systems (where Personal Data will be processed) and access authorizations are controlled at the level of individuals.

Organizational measures. We have adopted and commit to maintain the following measures:

- Our employees are bound by confidentiality;
- Our employees are properly trained and also receive further regular training regarding the GDPR and familiarize themselves with the rules of safe work with the work equipment;
- Access to all systems, including the information system, is personalized and protected by secure passwords.

4. WHAT RIGHTS DO YOU HAVE?

In connection with the protection of Personal Data, you are guaranteed the rights described below, which you can exercise:

How fast do we respond? We will respond within one week at the latest. If providing the information would compromise the privacy of others, or if providing it would be disproportionate to the risks or costs of providing it, we may not be able to comply. We may need to verify your identity in order to better process your request. In the event of a repeated request, the Controller will be entitled to charge a reasonable fee for a copy of the Personal Data.

to personal data

The right of access You can request a confirmation of whether we process your personal data.

You can request information on the purposes of processing, categories of personal data, recipients to whom they are

disclosed, the duration of processing, the existence of the right to request the controller to exercise one of the rights listed below. You can request a copy of the Personal data, but only in the event that the rights and freedoms of other persons will not be affected.

The right to correct inaccurate data

You can request correction of inaccurate Personal data. You can correct some information in your User Account.

The right to delete

If there is no other reason to continue Processing this data, we will delete or completely anonymise the data you have requested.

The right to restrict processing

If you believe that we are processing data incorrectly, either in terms of the purposes of the processing or the extent of the processing, please let us know.

The right to be notified of correction, erasure, or restriction of processing

If you contact us with a request, we will inform you of the result, unless this becomes impossible (e.g. the email address from which you wrote to us is no longer working).

The right to transfer personal data

We may transfer the data that you have provided to us in a structured and machine-readable format to another controller at your request.

The right to object to the processing of personal data

If we process your data on the basis of legitimate interest (e.g. sending you a newsletter), you have the right to raise an objection. It is up to us to prove our legitimate interest, if we cannot do so, we will stop this processing.

The right to withdraw consent to the processing of personal data

If you have changed your mind, please contact us. Processing for marketing and business purposes can be revoked at any time.

Automated individual decision-making including profiling

You have the right not to be the subject of any decision based solely on automated processing, including profiling, which would have legal effects on you or similarly significantly affected you. However, we state that we do not make automated decisions without the influence of human judgment with legal effects for Users.
